**Exhibitors may not arrive before 8:30 AM.** The building will not be open to exhibitors prior to this time so please do not arrive early. **Indoor crating space available – no ex-pens or large dog tents allowed inside.** Parking **MUST** be in the school's parking lot. No street parking allowed. **Please ensure cars are parked in an orderly manner. PER NJ STATE LAW - exhibitors will NOT be allowed to leave their cars running/idling in the parking lot.** Be prepared to crate indoors or leave your car with windows open/closed to keep your dog(s) cool/warm. Dogs **MUST** be crated when inside the building – dogs cannot be held on your lap or on leash at your side while waiting for your run.

**Exhibitor check-in will begin at 8:45 AM.** Please pick up your trial armband(s) for each dog entered and course maps. Check-in with the gate steward for each class prior to the beginning of the class.

Times below are **ESTIMATES**. Trial 2 Level 1 will not start before the time listed but **MAY** start later than the time listed. We can only **estimate** the time the first trial will take. We do our best to estimate how long it will take with a lunch break.

**Trial #1 Flash 1** walk-thru will begin at **9:00 AM**.

**Trial #1 Level 1** walk-thru will not start prior to **10:30 AM** (see class running order below).

**Trial #2 Level 1** walk-thru will not start prior to **1:30 PM** (see class running order below).

**NOTE: There will be a short lunch break after Trial 1 Level 3 and before Trial 2 Level 1.**

**Class running order:**

**Flash 1 (Trial 1), Flash 2 (Trial 1), Veteran (Trials 1 & 2), Intro (Trials 1 & 2), Levels 1, 2 and 3 (Trial 1), Levels 1, 2 and 3 (Trial 2)**

Final detailed running orders will be posted online during the week before the trials.

**NOTE:** If you have multiple dogs in a class, they will be separated in the final detailed running order.

These trials are **ONE** ring indoors on matting. Light breakfast items and coffee and tea will be provided for exhibitors. Bring water (for you and your dog), chairs, and lunch. **Lunch will only be available at the trial site for judges and volunteers.** There are a variety of restaurants (McDonalds, Frank's Pizza, and Chinese food) close to the show site.

Move ups will be accepted before and during the trial. Move ups will **NOT** be accepted via email – a Move Up Request form **MUST** be submitted. Please submit move up requests as early as possible **before** the trial, if known. Hard copy move up forms will be available the day of the trial, if needed.
